If no Early Redemption has occurred, the Redemption at maturity will depend on the performance of the Underlying. If no Barrier Event has occurred (European observation), the investor will receive a Cash Settlement equal to the Nominal Amount. Otherwise, the investor will receive a Cash Settlement calculated as the Nominal Amount multiplied by the Performance of the Underlying, as described under "Redemption".
